Commissioner's Meeting called to order at 7:00 pm, December 08, 2020.

Minutes of Dec. 01, 2020 approved by Motion from Com Colburn, seconded by Com. Aumand. Three in favor.

FIRE:

Chief presented invoices totaling \$ 9,241.65 approved by motion by Com Colburn, seconded by Com Aumand. Three in favor. Chief presented invoice for Code enforcement of \$ 120.00, approved by motion from Com Kiniry, seconded by Com Aumand. Three in favor.

Chief presented November Fire Department payroll for \$ 2,901.66, approved by motion, Com Kiniry, seconded by Com Colburn, with three in favor.

Chief noted that he had found a box of new bulbs and fixed the light in his office.

Chief noted that electrical work was needed to wire up chargers in the various lockers. Could be included in 2021 budget.

WATER:

Bob needs to know the schedule for PFAS testing; when last tested and when next test is due.

Bob has asked EAI to mark bottles so he can easily identify which ones to use for which tests.

Bob noted that he needs to order a barrel of chlorine.

Bob needs to contact Amerigas about propane delivery. He needs a delivery and has trouble now that all contact with them is an Ohio telephone number.

Patrick noted that last week, Eric Smith and E E Houghton & Co replaced the Fire Hydrant on Cray Road and that it is now in operation. We should receive invoice for the work by December 15th.

7:30 pm – Entered into Zoom Meeting with Samuel Kenney and Ethan Beaulier of Weston & Sampson for update of Water Treatment Project and answer questions.

Zoom meeting was to review where the project was and answer a few questions, such as complaints about brown staining and what initiates a backwash.

W & S would like a Trial#5, chemical trial with a modified permanganate dose. Pat & Bob will set that up after the meeting tonight.

Bob and Pat will meet with Samuel and Ethan on Friday, December 11 to tour the building and discuss procedures.

MISC:

Pat talked with Ted Biers of NHDES regarding the relicensing of Great River Hydro Dams on the Connecticut and reviewed some changes that are being planned. He will keep the Village informed of further developments.

Letters accepting the resignation of six fire fighters were signed and mailed today.

Celeste asked if the Fire Hydrants in the Village could be painted, as they are in need. Chief Crawford said he could get a crew together to service the hydrants (Grease the caps) and paint if the Commissioners wanted it done. Pat and Celeste volunteered to help.

Motion by Com Kiniry, seconded by Com Aumand to appoint William Crawford as Fire Chief of the North Walpole Fire Department for the year of 2021.. Three in favor.

Motion by Com Aumand, seconded by Com Colburn to adjourn the meeting at 8:20 pm, three in favor.
