Commissioner's Meeting called to order at 7:04 pm, December 29, 2020.

Minutes of Dec. 22, 2020 approved by Motion from Com Kiniry, seconded by Com. Colburn.
Three in favor.

MS. MAYBERRY:

Ms. Mayberry was attending to discuss the Sewer Pump Station on Killeen Street. Due to excessive flushing of wipes by residents, the pumps are becoming plugged and have had to be cleaned several times during the past few months. The system is old, which is adding to the problem. The Sewer Department is seeking USDA monies to replace the pumps; but the problem remains of the flushing of wipes. Ms. Mayberry will be posting notices asking residents to NOT flush wipes and any such items.

Com Kiniry commented about the snow plowing within the Village and especially around the Fire Station and Treatment building during the last snow storm. Apparently snow was plowed in such a manner as to block all the doors. He hoped that something could be done to alleviate this problem during future storms.

FIRE:

Chief had one invoice for \$150 and two payroll requests for shoveling hydrants for \$90. Motion to approve by Com Colburn, seconded by Com Aumand with three in favor.

Chief presented December Fire payroll for \$ 1,001.33, motion to accept by Com Kiniry, seconded by Com Aumand, with all three in favor.

Chief presented paperwork for new Fire Department member, Crystal Crawford.

Chief will send letters to recent members who left department, requesting any and all equipment belonging to the Department, be returned. Com Kiniry asked him to include request to reimburse the Village for training fees for courses not completed as per signed contracts.

Chief is contacting the State as to procedure for acquiring Covid vaccine for First Responders.

WATER:

Bob and Commissioners discussed recent water tests and comments from the Engineers.
Bob will add potassium permanganate to eliminate complaints of brown stain.

MISC:

Commissioners did first review of 2021 proposed budget. Chief Crawford will present his budget estimates for 2021 at next meeting.

Motion by Com Aumand, seconded by Com Colburn to adjourn the meeting at 8:25 pm, three in favor.
