## **FIRE**

Chief presented invoices totaling \$ 4366.15, approved by motion from Patrick, seconded by Melissa, with two in favor.

November payroll of \$ 1998.91 was presented and approved by Patrick and Melissa.

On Thursday, Engine#1 will go to Patriot Motors to fix the starting and other problems.

Department posted "Ice not safe" signs at 4 places in the Village.

Old Engine#1 has a broken mirror, which Chief will fix.

Patrick has talked with Greg Gay and Mr. Gay has given permission to park the Old engine#1 on his lot at 8 Len-Tex Lane. Capt. Colburn will drive the engine up and he and Patrick will cover it with a tarp.

Chief Crawford noted that State Line had corrected all deficiencies that he had noted on a recent inspection and is currently up to code.

The Departments report process to Firehouse/ESO has noted an increase in Dues up to \$2,000, which will require an increase in 2022 budget.

## WATER:

Bob attended an Operators Class at NHWW and received 5 credits on December 5, 2021.

Bob contacted NHDES regarding registering Lead & Copper Test Sites.

Invoice received from E E Houghton for installing a Fire Hydrant at the end of Willow Street of \$6,200.00 and for paving the end of Willow and fixing the shut off for a charge of \$655.56. This will be taken out of Line Maintenance.

Patrick noted receiving a "Letter of Deficiency" from NHDES. This is in regards to the 1,4 Dioxide problem. Village has to report progress on the progress to the NHDES.

Sam Kenney, W&S, advised they will aid in obtaining grant money for Infrastructure projects.

Patrick noted that GP wells #507 & 508 need new fence and gate replacements. Patrick will look into possible grants. Patrick noted that GP wells need to have pumps replaced. Cushing & Sons is looking into the cost, so a Warrant article can be posted in the 2022 budget.

Reconditioning of the Wells is nearly complete and #507 is back up and pumping 95% and #508 should be back in operation by Friday, December 10.
