## **FIRE**

Chief is trying to get the electrical wiring replaced in Engine 1, and is hoping that Ferrera will approve APG in Westminster VT to do the work, if not then Northeast in Maine.

Lisa Murphy has asked for information on the Fire Department to incorporate into the Town Master Plan.

Chief noted that they still need to install an exhaust system into the Fire Bays. There are grants available, which he will look into.

January 14/15 the NW Department will be doing Ice rescue training between 8 am and 5 pm, with class work taking place on Friday prior to going to the boat launch at the end of Pine Street. Chief has been working on his 2022 budget and presented his request for pay raises for the Department members.

After some discussion, Patrick made a motion to accept the Fire Departments payroll raises for 2022, effective as of January 1,2022, seconded by Celeste, with three in favor.

Jason Colburn, noted that a new door for the rear of the building run anywhere from \$537 and upwards. Chief noted that the door between the boiler room and the bays needed replacing also.

## **WATER:**

Bob has completed the Lead & Copper report for DES and it will be Emailed on Wednesday. Roughing filters were backwashed at 150/min.

Discussed classes that Bob needs in order to complete his license.

Floyd Lafoe will pick up the old unusable water meters on Wednesday.

Patrick noted that the new Backwash tank for thee WTB should be here the first week of February.

USDA is looking for the annual Water User report for 2020, which Patrick is working on.

Violation notices to residents of the Low system are tentatively planned to be hand delivered on January 22.
